

**Unit 128 Board of Governors Meeting Minutes

**Approval of Board of Governors Meeting Minutes from Zoom Meeting, February 16, 2024** by Jeff Overby.

Board members were referred to the Board of Governors meeting minutes that had been provided to them in advance of this meeting. After discussion, there were no corrections or amendments.

**Membership Chair Report** by Betty Sandifer

Board members were referred to the Lapsed Membership Report provided to them in advance of this meeting. Highlights of Report:

- We made our quota for the first quarter of 2024.
- We need to continue making calls to our lapsed and “at risk” constituents.
- This need to be an effort of all board members and if everyone made 50-75 calls, Unit 128 goals would be attained easily.

**STaC Coordinator Report** by Betty Sandifer

Board members were referred to the StaC Report that had been provided to them in advance of this meeting. Highlights of Report:

- The ACBL will be collecting proceeds from STaC games like they do for regular club games.
- ACBL will collect \$7.50/table for every StaC and give back \$2.30/table to the sponsor.
- Unit 128 will net less money from StaC than in the past, but challenging collection process will be eliminated.

**Stipend for YNABC** by Betty Sandifer

1. Motion was made by Tracy Nolan and seconded by Charlene Predmest to provide the Unit 128 juniors attending the YNABC in Toronto, Canada a post event stipend of \$500.00 per child. The attendees will provide receipts for expenses and will be reimbursed up to \$500.00 provided they play in 4 out of the 6 tournament sessions at the YNABC in Toronto, Canada. The motion was approved by unanimous vote.

**Treasurer’s Report** by Debbie Branch

Board members and advisors were referred to the Financial reports, provided to them in advance of this meeting.

Year-end Financials:

- Cash equals \$356,000
- Net Income was \$26,000
- 2023 Regionals netted a \$55,000 profit.

Year to Date Financials:

- Cash equals \$323,000
- Net income was minus \$12,000
- There have been no regionals year to date

Unit has 2 CDs yielding 5.6% and one MM yielding around 4%.

A motion to approve the Treasurer’s reports was made by Jeff Overby and seconded by Bruce Lang. The motion carried unanimously.

## **Proposed Reduction of Unit 128 Board Size** by Jeff Overby

Motion to amend the Bylaws and reduce the Unit 128 Board of Governors size as proposed in the document provided prior to the meeting as well as listed below was made by Jeff Overby and seconded by Jay Whipple. The amendment to the bylaws is effective immediately. A discussion was followed by a vote. A majority of the Board of Governors voted to approve the proposal with one abstention. Motion carried.

Flyers need to be created a year in advance and a process needs to be developed to reach this goal. Flyers for Sanibel and Daytona need to be available at the Palm Beach Gardens Regional.
