REGIONAL TOURNAMENTS REPORT: Jeff Overby

We may have too many Regionals. There is no indication that attendance is going up. Alternate years may be considered.

Unit 128 is committed to three years out for Regionals and cancelling will cause penalties. Jay suggested that we may shorten the tournaments. Player numbers often go down on weekends.
