- June STaC tables were up 20% from last year: 1,175 tables this year compared to 986 last year.

- Youth players need to have passports to participate next year in the Toronto YNABC.
- There is a need to better track the bridge activity of the youth who are receiving funding. Jesse

 players as needed.
- Going forward, stipends will be decided upon further in advance of the YNABC.
